## **Vendor Booth Assignments**

The Montpelier Center Farmers Market is located at 17205 Mountain Rd on the Village Green lawn in front of The Montpelier Center building. Booth spaces will be assigned by the Market Manager with consideration given first and foremost to special or personal needs of vendors (for example, adequate shade, special arrangement for vendors with physical limitations, then to individual preferences as to location on the lawn area. Vendors will receive notice of booth assignments before each market

Each vendor may park their vehicle in The Montpelier Center parking lot. If additional vehicles are used, vendors are asked to park them in the Hanover Parks & Recreation parking lot adjacent to the baseball fields in an effort to save parking for customers visiting the market. Vendors may use the pull through to unload their vehicles close to their assigned booth spaces before parking in a lot space during the market.
