The **SOUTH-ATLANTIC JURIED EXHIBITION** is open to all professional artists who reside in Maryland, West Virginia, Virginia, Washington, DC, North Carolina, South Carolina, Georgia, and Florida. *Artists are invited to submit up to **three** works completed within the last two years and not previously shown at the Montpelier Center.* Show entry implies consent for The Montpelier Center to use images of any accepted artwork for marketing and publicity purposes.

### **RULES FOR ENTRY:**

**Up to 3 entries** per artist may be submitted for a non-refundable entry fee of **\$40**.

All completed entry sets must include the **entry form, fee, and JPG images sent by email to [allyson.catoe@montpeliercenter.org](mailto:allyson.catoe@montpeliercenter.org)**

All digital image files must be saved as high resolution, 300dpi images in standard *JPG format no larger than 5MB with each JPG titled as: *titleofpiece\_lastname.firstinitial.jpg** (ex: Waterway\_Jones.C.jpg).

**Monday, April 12, 2021** is the submission deadline for entries and fees to be received.

### **NOTIFICATION OF ACCEPTANCE:**

**Monday, April 19, 2021** is the notification date of the juror's selections for entries into the exhibition. These will be announced at [www.montpeliercenter.org](http://www.montpeliercenter.org) and via email.

### **SALES:**

The Montpelier Center will collect a commission of 30% of the sale of any artwork during or as a result of this exhibition.

**All artwork is required to be priced for sale and will remain on display for the entire exhibition.**

### **CONDITIONS:**

***All submitted works must be original: no reproductions or giclee prints!***

Entries made for this exhibit must be two dimensional and limited to the following media: painting, drawing, pastel, mixed media collage, traditional printmaking media, original black and white photography produced and printed by the photographer in the wet darkroom or original digital photography produced and executed by the photographer.

Although the beauty and expression of the nude figure is part of both traditional and contemporary art establishments, this genre is not part of this exhibit. The Montpelier Center reserves the right to exclude work that is deemed not to be suitable for viewing by audiences of all ages.

**PRESENTATION of Selected Submissions:**

Works must be professionally framed or gallery wrapped canvas with painted edges and **wired for hanging**. Works must be completely dry and cannot exceed 60" inches in height or width, weigh more than 50lbs. Contact Identification information *must be on the back of each piece*.

**Contact Identification Information:** The title, medium, size and artist's name and contact information must be securely attached to the back of all presented work. (Please use the provided *show labeling* documentation.)

*Works presented with wet medium, saw tooth hangers, inadequate framing, or inadequate wiring poorly attached and not capable of withstanding weight of artwork will NOT be accepted.*

**The decision of the judge of the Annual South Atlantic Juried Exhibition will be final!**

**DELIVERY/PICKUP:**

**Hand deliver on Monday, May 10.** Representatives of The Montpelier Center will be onsite to receive artwork from **10am –1pm**. If submitting from out of state, please contact us for specific mailing requirements.

Artwork should be delivered to The Montpelier Center for Arts & Education, 17205 Mountain Road, Montpelier, VA 23192. See [www.montpeliercenter.org](http://www.montpeliercenter.org) for directions. If using GPS, please include our zip code 23192 to prevent confusion of location.

**Exhibited artwork must be picked up at The Montpelier Center on Wednesday, July 14, 10am – 1pm.**
